Orders

Orders placed are normally dispatched within three working days. A later date can be requested by sending an email to originalcakeshop@banburycakes.co.uk. Customers will be notified when their order will be dispatched. Orders are dispatched via Royal Mail first class or airmail services. Their specified delivery schedule is UK First Class 1 to 2 days, airmail to Western Europe within three working days. Eastern Europe takes up to five days and other countries up to seven days

All items are subject to availability. The date and time of delivery shall not be the essence of the contract and any failure by us to make delivery on any particular date shall not entitle the customer to refuse the delivery or to claim for any expenses, loss of profits or other consequential losses whatsoever. Email confirmation of an order should be taken as an invitation to treat and not receipt for the order. Ownership of the goods will pass to the customer on receipt of payment and dispatch of the goods. We will inform you as soon as possible if the goods you have ordered are not available.
